## STATE BOARD OF DENTISTRY RENEWAL

Renewals are available 60 days prior to the license expiration date. You will receive an email notification from the Pennsylvania Licensing System (PALS) when your renewal is available. There are no paper renewal applications. Renewal applications must be submitted on [www.pals.pa.gov](http://www.pals.pa.gov).

## DEPT OF STATE CE REQUIREMENTS

Pennsylvania dental licenses renew on April 1<sup>st</sup> of each odd-numbered year. In that two-year period, dental professionals must obtain a specific number of hours of continuing dental education. A maximum of 50 percent of the required credit hours (EVERY TWO YEARS) may be taken through individual study. The remaining 50% must be earned through attendance at lectures or live webcasts that allow attendees to communicate with the presenter and other attendees.

Dentists: 30 hours  
Dental Hygienists: 20 hours  
EFDAs: 10 hours

## CHILD ABUSE RECOGNITION AND REPORTING TRAINING FOR MANDATED REPORTERS

Child abuse consists of all forms of physical, emotional and sexual abuse, including neglect and exploitation. As healthcare professionals, we have an obligation to report any indicators or signs of child abuse. Approved by the Pennsylvania Department of State, this mandatory course must be completed to renew your professional license. *(2 CE credits)*



Healthcare professionals in Pennsylvania are required to report child abuse and neglect, but many others are also required to report such abuse and neglect, including dental and medical assistants, nurses, educators, school employees, and law enforcement officials. This presentation aims to review the law and educate our audience on being vigilant, reporting suspicious cases, and saving lives. 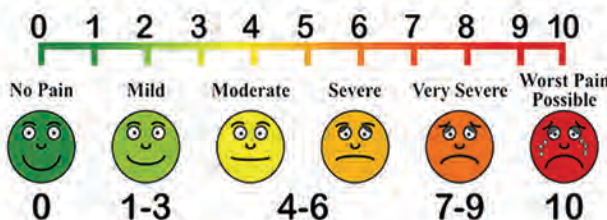
## PAIN MANAGEMENT, PRESCRIPTION WRITING AND DRUG ADDICTION SERIES

For quite some time, opioids seemed to be the answer to the problem of relieving pain without putting patients at risk of addiction. As it turns out, that was wishful thinking. ## MEDICAL EMERGENCY SERIES
